In this Agreement, the party who is contracting to receive the services shall be referred to as "**Sponsor**", and the party who will be providing the services shall be referred to as "**Stardust**".

A. DESCRIPTION OF SERVICES. Beginning on (Date) _____, "**Stardust**" will provide the following services.

 - *All trips will be reserved in advance, and are based upon availability.

- (3) Your business will be featured on three different pages of our web site with reciprocal links.
- (4) All your employees become members in our VIP Club as a bonus to them from you.
- (5) Two complimentary tickets on one of Stardust Cruises Limousine Services familiarization tours in 2009.
- (6) You receive entry into our 3 day Mexican Cruise, plus \$500.00 in spending money. Estimated value \$1,100.00.

3. TERM/TERMINATION. This Agreement shall terminate automatically on January 31, 2010.

4. RELATIONSHIP OF PARTIES. It is understood by the parties that "**Stardust**" is an independent contractor with respect to "**Sponsor**", and not an employee of "**Sponsor**". "**Sponsor**", will not provide fringe benefits, including health insurance benefits, paid vacation, or any other employee benefit, for the benefit of Service

5. ENTIRE AGREEMENT. This Agreement contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written.

6. SEVERABILITY. If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.
